PARTICIPANT'S AGREEMENT

WARNING: This is a legal document that affects your rights.

- 1. I acknowledge that aquatic activities involve the real risk of serious injury or even death from various causes including overexertion, equipment failure, dehydration, accidents with other entrants or spectators, course or weather conditions and other causes.
- 2. I understand that NSW law provides that life jackets must be worn in NSW waters. Requirements are set out in Marine Safety Regulation 2016.
- 3. I understand that I should not enter in this event unless I have trained appropriately and my physical condition has been verified by a medical practitioner.
- 4. By participating, I accept all risks necessarily flowing from my participation which could result in loss of life or permanent injury. Accordingly, I release all persons or corporations associated directly or indirectly with the conduct of the event from all claims, demands and proceedings arising out of my participation and I hereby indemnify them against all liability (including liability for their negligence and the negligence of others) for all injury, loss or damage arising out of or connected with my participation in this event. This release shall extend to and include Brunswick Surf Life Saving Club Inc., Marine Rescue NSW, Brunswick Heads Chamber of Commerce Incorporated and their respective directors, partners, managers, officers, agents, contractors, employees and volunteers including medical and paramedical personnel appointed for the event, the owners, licensees and occupiers of land upon which the event or any part of it is conducted, any statutory body or local authority having control over any land upon which the event or any part of it is conducted or which is involved directly or indirectly with the event in any manner whatsoever and promoters, sponsors and event organisers.
